This addendum contains important updates to your Evidence of Coverage and Summary of Benefits. Please keep these documents together.

Medicare Diabetes Prevention Program (MDPP): CMS has announced beginning April 1, 2018, MDPP services will be covered for eligible Medicare beneficiaries under all Medicare health plans. MDPP is a structured health behavior change intervention that provides practical training in long-term dietary change, increased physical activity, and problem-solving strategies for overcoming challenges to sustaining weight loss and a healthy lifestyle.

The Centers for Medicare & Medicaid Services (CMS) has announced the CY 2018 Part A premiums and deductibles, and the Part B premiums and deductibles. This information will replace the 2017 cost share amounts listed in your 2018 Evidence of Coverage and Summary of Benefits.
